APPROVAL OF MINUTES:

Acting Chairman Grove asked members if they had any comments or corrections regarding the Meeting Minutes dated October 5, 2023. No discussion followed and Member Giffin made a motion to approve the Meeting Minutes which was seconded by Member White and passed by a vote of 4-0.

Acting Chairman Grove then asked members if they had any comments or corrections regarding the Meeting Minutes of November 1, 2023. After discussion, a question was raised about the last bullet point in the items discussed regarding the Northstar Development Plan interaction with Skip Weiler. Member White made a motion to change it from ...consensus ON minimum lot widths... to ...consensus to consider minimum lot widths. He further stated that he thought that is what was meant by those in attendance at that meeting. A second was made by Member Giffin and the amendment passed by a vote of 4-0. A motion was made by Member White to approve the Amended Meeting Minutes of November 1, 2023, the motion was seconded by Member Giffin and passed by a vote of 4-0.

Resident Bob Leone asked about Homeowner Associations (HOA's) and whether Kingston Township had authority to regulate or intervene in HOA actions. Considerable discussion ensued regarding the positive and negative merits of whether the township should have regulatory authority over HOA's. A second topic was discussed as to whether Kingston Township residents

will have access to the Northstar multiuse paths that will be connected to the paths that are built on the Kingston Township land north of Northstar?

Member Smith asked if Kingston Township could mandate and enforce HOA rules. Upon further discussion, the Zoning Commission asked if the Zoning Secretary could research this question in relationship with the Comprehensive Land Use Vision Statement.
