ISO Rating

Porter Kingston Fire District is proud to announce that we have been awarded an ISO Rating of 4/4Y.

So what exactly is an ISO rating, and what does this new rating mean? ISO stands for Insurance Service Organization, and they evaluate and assess fire protection in municipalities and counties throughout the U.S. In each community, ISO analyzes data on fire protection (generally from what is known as a Fire Suppression Rating Schedule or FSRS) and assigns the district a Public Protection Classification number. These numbers are like a grading system, and range from Class 1 (most desirable) to Class 10 (least desirable).

The test is divided into three different areas including Fire Department, Water Supply System, and Communications System. The Fire Department section accounts for 50% of that final scoring. The other two evaluated areas are water supply, which accounts for 40%, and communications, which is 10% of the overall rating.

What does this mean to our district and you? Most insurance companies utilize the ISO ratings when calculating your premium (although some carriers use a different format). Our previous ISO rating for the Fire District was a 6/9, the new rating of 4/4Y, puts our district in the top 17% of all fire departments in the country. Please check with your insurance carrier, to discuss our new ISO rating and see what kind of a difference it can make for you.
