## 2021 TRUSTEE ORGANIZATIONAL MEETING

At their January 5, 2021 Organizational Meeting, a number of appointments and resolutions were passed for 2021 including:

- Delaware County Prosecutor retained as the township's legal counsel

- Established the first Tuesday of the month for Trustee Meetings at 7:00pm
- Bob Talbott renamed Zoning Inspector
- Dave Stites renamed Zoning Secretary and Regional Planning Representative
- Renamed current Members of the Zoning Commission and Board of Zoning Appeals
- Renamed Doug Crowl Road Superintendent and Cemetery Sexton
- Continued current Zoning Fees and Cemetery Fees and Rules
- Set the Mileage Reimbursement Rate at \$.56 cents per mile
- Certified official roadway mileage as 18.70 miles
- Approved \$1,218 for Emergency Services Fee Assessment
- Approved \$1,510 for Regional Planning Membership Dues
- Approved \$2,932 for Health District Apportionment
- Adopted Public Records Policy

## **ROADS & CEMETERIES**

#### State Route 61/656 Roundabout

The Ohio Department of Transportation (ODOT) continues design work for the proposed roundabout at the intersection of State Route 61 and State Route 656/Wilson Road. The shape of the roundabout will resemble a peanut, and minimizes the project impact on adjacent neighbors. The target bid date is January 2021 with construction during the summer months. Tentative traffic closure will occur between June  $1^{st}$  and October  $31^{st}$ . The total estimated cost of the project is \$2.1 million dollars with \$310,000 coming from an OPWC grant, \$17,250 from the Delaware County Engineers Office, and \$17,250 from Kingston Township. ## Since The Last Newsletter

For the months of November and December, 2020, and January 2021, 6 driveway permits were issued, and approximately 50 tons of salt was applied to Township roadways for public safety.

The township continues to work with the County Engineers Office and impacted residents for the installation of a new drainage culvert under Todd Street Road and drainage improvements on the south side of the roadway.

## **DID YOU KNOW?**

## Kingston Township's Stark Cemetery

Nestled quietly along State Route 656 between Olive Green and State Route 61 sits the Stark Cemetery that is shared by Porter and Kingston Townships. One might wonder why this cemetery was established in its current location. The answer begins over two hundred years ago in 1809; four years before the establishment of Kingston Township in 1813.

In 1809, James Stark emigrated from the Wyoming Valley in Pennsylvania, and settled in the eastern part of the future township on 200 acres of land. The intersection of the north/south Sunbury-Mansfield Road and the east/west Mount Vernon-Berkshire Road crossed on his property which eventually was named Stark's Corner. That name is still used today for the intersection of State Route 61 with Wilson Road to the west and State Route 656 to the northeast.

With travel increasing on the roadways, James Stark and his second wife Miss Elizabeth Wilcox opened a "House of Entertainment" for travelers in their home. Their establishment was the only hotel ever operated in Kingston Township. Their white, two story home/hotel still exists at the roadway intersection today. The Starks had one son named James N. who prospered in both farming and "mercantile pursuits", and at one point he owned about 2,000 acres of farm land and in Porter Kingston Townships.

James Stark's nephew, Oliver Stark, came to Kingston Township in 1825, and settled just south of James. He married Miss Eliza Patrick who was the first white child born in the township. Oliver was a Justice of the Peace for 21 years and served as a County Commissioner from 1846 to 1849.

Both James and Oliver were dedicated members of the Methodist Episcopal Church. James and Elizabeth donated a portion of their land to the church for both a house of worship and adjacent burial area. The church building was constructed in 1836 and was used for seventeen years. With the building in disrepair and finding refurbishment costs exceeding the cost of constructing a new building, a larger building was built by the congregation in Olive Green in 1853. The church land was then deeded to the Trustees of Porter and Kingston Townships.

Grave stones in the original cemetery ground date back to 1818. As the need for more space grew, John VanSickle deeded property to the Trustees, and in 1876 a final parcel was purchased by Porter and Kingston Townships from James and Mary Sherman. These three parcels comprise the Stark Cemetery consisting of approximately 2 1/2 acres, and the cemetery is the resting place for many of the early settlers of both townships with interesting stories.

One such story involves a Native American Indian whose name is not known. The Indian returned from the West with resident Reverend Chase. One winter, the Indian went to Big Walnut Creek, and cut a hole in the ice to bathe. The temperature of the water was too severe; he became sick, developed pneumonia and died. He was buried in Stark Cemetery by the Chase family. There is not a marker at his grave.

Today, Stark Cemetery is still owned and maintained by Porter and Kingston Townships. The Kingston Township portion to the south has been closed for burial use for many years, but the Porter Township portion to the north is still active. Vehicular access to the cemetery is very limited with a small pull off area for one or two cars located at about the midpoint of the cemetery grounds. Parking along State Route 656 is ill-advised due to topography, line of sight distance limitations, and volume of traffic on the roadway.



#### Santa's Visit

As is tradition, Santa made a special trip to Porter Kingston Townships and on December 20<sup>th</sup>. Riding aboard the Fire Districts pickup truck and accompanied by Engine 382, Santa began his road tour at 11:00am and finished up 10 1/2 hours later at 9:30pm. Over 1,100 residents of all ages greeted Santa from their driveways; Santa even had an opportunity to spread Christmas Cheer to about 60 different family pets and animals. The children that visited Santa also had an opportunity to put a letter to Santa in a special mailbox mounted on the pickup truck.

#### Safe Haven Baby Box Installed

On January 5, 2021, the BST&G Fire Station 380 dedicated a Safe Haven Baby Box at 350 W. Cherry Street in Sunbury. The State of Ohio Safe Haven Law allows people to anonymously surrender their healthy newborn baby without criminal prosecution at any fire station, police station or hospital as long as the child appears to be 30 days or less and unharmed. The Safe Haven Baby Box is a final resource for women in crisis who want 100% anonymity to ensure their baby's safe surrender.

The cost for box installation was primarily funded by a grant from Discount Tire Drive to Care Foundation. Table Rock Construction donated time and materials for the installation. Support donations were also made by Sunbury United Methodist Church and Sunbury Christian Church. The grant will also support a local billboard campaign in the community and surrounding area. No tax dollars were used for the project.

Safe Haven Baby Boxes are equipped with alarm systems to notify fire district staff immediately. The boxes also have heating and cooling features and the outside door locks as soon as a baby is placed inside.

## **Cares Act Funding**

In November, 2020, both Porter and Kingston Townships learned that Federal CARES Act funding could be utilized by the Porter Kingston Fire District (District) to support/protective equipment purchase directly related to the management of the Covid-19 Virus crisis and protection of personnel. Both townships quickly passed resolutions appropriating the use of the funding, and the District immediately support/protective equipment purchased including replacement turn-out gear for all firefighters, touchless restroom and drinking fountain modifications, computer, monitor and camera to facilitate remote meetings and training functions, washer and dryer to


immediately clean exposed clothing, and a cardiac heart monitor with automatic external defibrillator ahead of a December 30, 2020 deadline for expenditure of funds.

Funding in the amount of \$133,313 was expended by the District; \$38,870 from Porter Township and \$94,443 from Kingston Township. These funds provided sorely needed support for the District's normal operating budget related to managing the virus; improving operational efficiency, effectiveness and safety of personnel. The District is extremely appreciative of the efforts made by the Porter and Kingston Township Trustees and Fiscal Officers to make the funds available to the District.

## **Engine Rescue 381 Refurbishing**

In late February, 2020, ER381 was taken out of service due to safety concerns when it was discovered that the chassis frame rails were severely rusted. A bid package was advertised for the chassis work, and two bids were opened by the Fire Board (Board) at their monthly meeting on January 11, 2021. Upon review, the Board approved the bid submitted by Pierce Manufacturing for \$113,000 to remove the engine, cab, pump, suspension, and rear box from the rusted chassis, and reinstall the components on a Components such as the new chassis. radiator and brakes will be inspected during the refurbishment process, and will be repaired or replaced as needed. The unit will be transported from Olive Green to Wisconsin on a flatbed truck, work will take approximately 6-8 months to complete, and the unit will be ready for full service upon return.
