OLD BUSINESS: Trustee Volpe discussed the 4 Project steps of Kingston Park.

Project 1 is the Phase I Park Development. This includes site grading and drainage, road work (Access Drive) and Utilities (Power, Gas, Water, Sewer, Cable). Project 2 is the Township Hall possible dates of June or July. Project 3 is the Picnic Pavilion/Shelter House. This will be completed by Nationwide Realty (The Developer). Project 4 is Phase II Park Development. This will be further clearing, grading and construction of bike paths.

**ROADS:** The Estimated Road Improvement Project for 2020 is approximately \$49,390. This is for Blue Church Road (from Rosecrans Road to Wilson Road) for chip seal, and a fog seal. And Blue Church Road (from Wilson road to 521) This will also be a Chip seal with a fog seal.

A motion by Volpe was made to proceed with the County Construction Cost Estimate as submitted, with a second by Shively. Vote: Shively-yea; Akers-yea; Volpe-yea.

Trustee Shively discussed with Mr. Reidel possible sign upgrades for the intersection of State Route 521 and 3B's & K Road. Trustee Shively reported an accident at this Intersection which resulted in a fatality. Since this intersection is a state highway and a county highway, the state (ODOT) and Delaware County Engineers Office will need to be involved with the project. The Trustees will support the effort to improve the intersection. A letter will be drafted to the Ohio Department of Transportation District #6 representative.

With no further business, a motion by Akers was made to adjourn the meeting until March 3, 2020 which will be the regular Board of Trustee meeting. Second by Volpe. Vote: Shively-yea; Akers-yea; and Volpe-yea.
