
OTHER BUSINESS:


There will not be any voting on May 2, 2023 at the Kingston Township building. There are no items to vote on at this time. The next election will be in November.


With no further business, a motion by M. Roy was made to pay the current bills, and to Adjourn the meeting until May 2, 2023. Second by Shively.
